ANNUAL (12 MONTH) COMPANY MEMBERSHIP FEES FROM 1 OCTOBER 2024

ADHESIVE AND SEALANTS MANUFACTURERS AND DISTRIBUTORS

Subscriptions are based upon total <u>relevant</u> annual sales turnover in the UK and Ireland to include all products manufactured in the UK and Ireland for domestic or export consumption plus products imported for sale in the UK and Ireland. Relevant products include adhesives, sealants and directly related ancillary products such as hardeners, primers, application equipment and adhesive/sealant raw materials. Rates are on a sliding scale and are calculated as a percentage of the relevant turnover in GBP up to a capped rate of £15,000. Relevant turnover is re-assessed every 3 years via a self-declaration.

GROUP MEMBERSHIP

Companies may subscribe either on an individual or group company basis. If Group Membership is chosen, total turnover is combined to determine the subscription band. Qualifying companies within the Group may be listed in the BASA Handbook, on the website, in other promotional material, and in circulation lists, but the Group will be entitled to only one vote in any Association ballot.

RAW MATERIAL SUPPLIER MEMBERS (RM)

Flat fee membership is offered for raw material supplier companies (see also Group Membership), and fees are calculated on the relevant turnover band. Any change in the basis is subject to the six months' notice requirement. Relevant turnover is re-assessed every 3 years via a self-declaration.

ASSOCIATE SUPPLIER MEMBERSHIP (AM)

Associate membership is available for members whose business is not directly related to the supply of raw materials or adhesives and sealants.

CONSULTANCY MEMBERSHIP (CM)

Consultants can apply for membership if their business is relevant for the sector and a flat fee of £320 is charged for turnover under £250,000. Fees are calculated based on the size of the consultancy turnover in the sector if greater than £250,000. Relevant turnover is re-assessed every 3 years via a self-declaration.
